The Organization is involved in the Childhood Healthy Weight Initiative of the Greater Rochester Health Foundation as a sub-contractor for project coordinators at five of the eight elementary schools involved in the initiative. This Organization assists the goals of the project to increase the percentage of 4 to 10 year-olds in the city who are at a healthy weight by increasing student healthy eating and physical activity at the schools involved.

4b (Code: ) (Expenses \$ 44,016. including grants of \$ ) (Revenue \$ ) Give Back, Give Books: The Organization has continued this program with a new emphasis on collaboration among educators and additional support for arts-related books. The group gives educators up to 200 new books apiece through the competitive Teachers' Choice program. All of the books, with the exception of a class set, are given to students at the end of the school year to keep for home libraries. This program is primarily supported through contributions.

4c (Code: ) (Expenses \$ 43,382. including grants of \$ ) (Revenue \$ 48,749.) Student Careers Program - National Academy Foundation (NAF): This program is being phased out of RCSD schools. This occurred at the same time that the Organization was moving away from supporting student internships through the NAF program. However, the Organization still supports student internships through the Law Camp program.
